

## **PRIVACY POLITICS OF “DIFFERENT & EQUAL” ORGANIZATION (D&E)**

### **1. General information for D&E**

"Different and Equal" (D&E) is a nonprofit organization (NGO) created in May 2004 and provides preventive, protective and reintegration services for victims of trafficking, victims of violence and vulnerable groups.

The planning and implementation of the activities of the "Different and Equal" organization are guided and met by the lines of strategies and national action plans for the fight against human trafficking and the fight against gender-based violence and domestic violence as well as the obligations of the organization as a member of the National Referral Mechanism for victims of trafficking.

#### **Vision of the organization Different & Equal**

We believe in a society without trafficking, exploitation or discrimination where everyone's rights are respected and they are free to pursue opportunities equally.

#### **Mission of the organization Different & Equal**

D&E is a nonprofit organization dedicated to providing qualified services for the protection and reintegration of victims of abuse, exploitation and trafficking, and to changing the legal, institutional and social context to counter these abuses.

#### **Activities and services provided by D&E:**

- Residential and community services;
- Activities to facilitate and increase access of victims in public services;
- Community awareness about the consequences of violence and trafficking and the rights of victims;
- Activities for the evaluation of the formal labor market and increasing the access of victims to it;
- Technical and financial support for income generation and self-employment of victims;
- Activities to fight stigma and discrimination against victims of gender-based violence including victims of trafficking and those of sexual abuse;
- Training for NGOs, state institutions and business companies;
- Studies and evaluations of the process of reintegration of victims of gender-based violence;
- Participation in the process of identifying victims;
- Lobbying and Advocacy;
- Support for policy making
- Prevention – Awareness raising; empowerment of vulnerable groups
- Information and technical advice on drafting laws and legislation to protect children, victims of trafficking and domestic violence.

## **2. Information gathered by visitors and the security policies**

D&E does not collect personal information for the visitors of our website, if the visitor does not want to share this information with us.

Sharing or giving information voluntarily through our website or through D&E's contacts means that you have given your permission to use this information for the stated purpose and in the function of the D&E's overall mission.

D&E automatically processes and keeps the name of the field from where you have access to the Internet, the date and time when you visit our website; the web site address (including the google search page or referral page) from which you visited our site. D&E uses the gathered information to count the visitors of our site and to help us making our site more useful to visitors like you.

## **3. Obligation to preserve confidentiality**

D&E and all its staff, processors and third parties contracted by D & E who have access to the data received from you or those who knew the processed data while practicing their functions, are obliged to maintain confidentiality and reliability even after finishing the function. These data shall not be disclosed except the cases foreseen by the law.
